

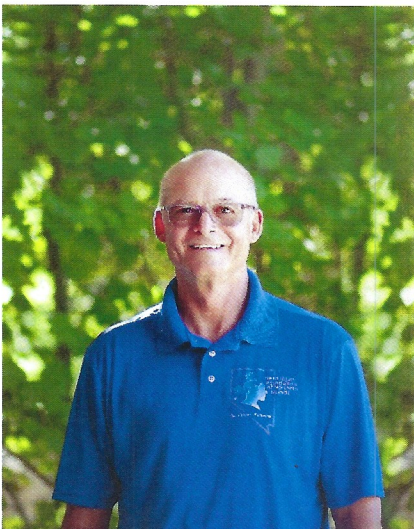


## Head Injury Association of Northern Nevada Leadership Biographies

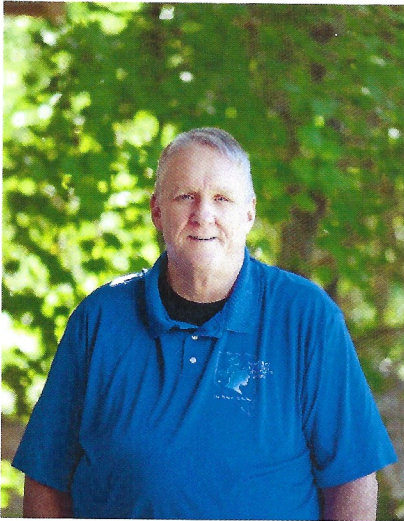
### OFFICERS:
